# DRESSAGE AT GINGERWOOD STATEMENT OF PRINCIPLES

Dressage at Gingerwood supports adherence to humane treatment of horses in all events the organization presents.

Dressage at Gingerwood is committed to:

- Upholding the welfare of the horses, regardless of value, as a primary consideration in all activities.
- Requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to mistreatment.
- Ensuring that owners, trainers and exhibitors or their agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose.
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure.
- Continuing to support scientific studies on equine health and welfare.
- Requiring owners, trainers and exhibitors to know and follow the organization's rules, and to work within industry regulations in all equestrian competition.
- Reviewing, revising and developing competition rules and regulations that protect the welfare of the horses.

The standard by which conduct, or treatment will be measured is that which a person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive, nor inhumane.



# **RULES AND CONDITIONS**

#### **MEMBERSHIP**

1. Current EC Sport Licence **is NOT required** to be eligible to participate as a rider, owner, lessee, agent or anyone schooling at the Dressage at Gingerwood Schooling Competition

#### **EC HORSE RECORDING**

2. For the schooling competition EC Horse Recording is NOT required

# **VACCINATIONS**

3. All horses attending Dressage at Gingerwood Schooling competitions must have met the requirements, Vaccinations, as follows:

"All horses attending Dressage at Gingerwood Schooling competitions must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave event site at the discretion of Competition Management.

"The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements.

"In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the entry form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested."

Dressage at Gingerwood show organizers recommend that your horse have a negative Coggins Test and recent Rhino virus inoculations. In addition, we recommend that your horse be immunized against Strangles.



# **ENTRIES**

- 4. Entries must be received no later than May 20, 2024. Late entries, if accepted, will be charged \$45.00 per horse. Late entries will not be accepted on the day of the competition.
  - The completed entry must supply all information required and payment of fees.
- 5. Entries will be accepted by e-mail or mail
  Mail or E-mail entries must be paid by cheque or e-transfer to <a href="mailto:secretary@dressageatgingerwood.com">secretary@dressageatgingerwood.com</a>
  Entries may have to be limited. In this case, completed entries will be prioritized initially by online entry and subsequently by the earliest date received through mail or email. Please note that many classes are small and, consequently, riders with multiple horses may not have much time between rides.
- 6. No horse may be entered in more than two levels at the same competition and these levels must be consecutive.
- 7. Non-Compete Entries accepted based on stall availability. Non-Compete Entries must pay show organization fee \$55 plus stabling.
- 8. A parent or guardian must sign the entry form in the case of a junior competitor and may sign as a Person Responsible.
- 9. STABLING: Stabling is available on a first-come, first-served basis and required for all competitors. Show grounds open at noon on Friday. Please book your stall with entry. Please respect stall signs upon arrival. All stall users are required to clean out their stalls totally before departure. Shavings will be available at cost to competitors or may bring their own bedding (no straw please). Please note a limited number of tack stalls will be available.
- 10 Scoring will be done online through Compete Easy. Live up to date scores will be available through the Compete Easy app which can be downloaded on any mobile device. Test sheets will be emailed to riders. Please ensure a valid email address is submitted with your entry to ensure the receipt of test sheets after the completion of each class.

# HORS CONCOURS

- 15. With permission of the organizing committee, horses may be entered hors concours (non-competitive).
  - a. Hors concours entries are not eligible for prizes, placings or awards.
  - b. Such entries must pay the full entry fee and are subject to all rules.
  - c. A horse may be ridden both as an hors concours entry and a competitive entry at the same competition. The maximum number of tests ridden, whether competitive or not, is four per day including freestyle.

# **REFUND POLICY**

16. After closing date, refunds of 50% of entry fees (not including Show Organization fee & stabling) will be granted with a veterinarian's certificate. There are no refunds after the start of the competition. Horse substitution will be permitted.



# **COMPETITION GUIDELINES**

Dressage at Gingerwood recognize 3 categories of competitors:

CLASS CATEGORY	ELIGIBILITY TO COMPETE
Open (O)	All competitors (regardless of age and/or amateur/professional status)
Adult Amateur (Am)	All athletes who are no longer Juniors
Junior (Jr)	Open to all athletes until the end of the calendar year in which they reach the age of 18.

# **MASTERS TEST OF CHOICE**

The Masters Test of Choice is a dressage class that provides senior riders, 60 years and older, the opportunity to participate in a dressage class that is exclusively their own in an environment that provides a fair playing field for senior riders wherein each will compete against their peers at all levels of skill, from beginners to advanced.

#### **DETAILS:**

- A. Masters classes are open to riders 60 years of age and above.
- B. The class is included in the competition prize list with the appropriate entry fee.
- C. The class will feature one test per day and may have a class championship.
- D. Masters riders may also compete in non-Masters dressage classes.
- E. To facilitate ease of riding, the following accommodations are available in the Masters Test of Choice:
  - i. Rising trot is optional in all trot work.
  - ii. Callers/riders may use headsets (someone, e.g., a competition appointed supervisor may stand beside the caller to ensure no coaching takes place).
  - iii. Entry bell/whistle can have a secondary indicator (e.g., the caller can raise an arm once the bell rings).
  - iv. Use of voice
  - v. Equipment accommodations may include any or all of the following:
    - Looped reins
    - Converters on double bridle to create single rein.
    - Gel or fluffy seat covers; and/or,
    - Two whips.
- 3. Riders may enter **two categories** at each level. For example, if eligible, a rider could compete in both Junior and Open categories.
- 4. A horse/rider combination may compete in any two consecutive levels and a maximum of four tests per day
- 5. More than one athlete may compete on the same horse, but the horse may not compete against itself.
- 6. All tests can be found on the Equestrian Canada website.
- 7. The total length of the whip (including lash) must not exceed 120 cm.

# **FREESTYLE**

Freestyle music (MP3 file preferred) must be emailed to secretary@dressageatgingerwood.com before May 20, 2024. The email must contain competitor's name, horse's name, class #, and instructions (if any). Times for sound checks will be Friday May 24, 2024 at 6:00pm. Note that there will be no sound manipulation – music will be played as received.



# **GENERAL**

- 1. All riders are required to wear approved protective headgear at all times when mounted.
- 2. Ride times will be available on website: www.dressageatgingerwood.com and posted at the stable.
- 3. Ribbons & prizes will be handed out at the ribbon booth after the completion of the show. Championship awards will be awarded during presentations and riders must be present to receive awards.
- 4. Lunging (mounted) is not permitted under penalty of elimination. Lunging will not be permitted in the warm-up ring if another rider is present. Riders in the warm-up ring are asked to pass left to left and to maintain a respectful (1.5m) distance from other riders.
- 5. The Competition Committee reserves the right to govern all conditions of the competition and its entries.
- 6. Gingerwood Farm, Dressage at Gingerwood will not be held responsible for damage, injury or loss to persons, horses or property of exhibitors or spectators.
- 7. Any competitor submitting an N.S.F. cheque will be required to pay the full amount plus any bank charges and \$10.00 in cash within 14 days of notification. The competitor will then be required to pay all future competition fees in cash or by money order for one calendar year.
- 8. In the case of cancellation, competitors will be notified.
- 9. All tests will be ridden in 20 metres x 60 metres ring.
- 10. Competition numbers must be worn and be visible in schooling and exercise areas and the competition ring at all times. Protective head gear must be worn when mounted on show grounds.
- 11. A competition may reserve the right to refuse an entry providing the reason for refusal is clearly stated in the prize list

I am aware that there are inherent dangers, hazards and risks (collectively "Risks") associated with "Equine Activities" and injuries resulting from these "Risks" are a common occurrence. I am aware that the "Risks" of "Equine Activities" mean those dangerous conditions which are an integral part of "Equine Activities", including but not limited to: (a) the propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick other animals, people or objects; (b) the unpredictability of an equine's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects; (c) the potential for other participants to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over an equine. the potential of natural or man-made hazards being present that can cause me harm, including communicable disease.
