# **GENERAL RULES & REGULATIONS**

Dressage at Gingerwood competition is sanctioned as Gold and Bronze Competitions by Equestrian Canada, c/o House of Sport, 2451 Riverside Drive, Ottawa, Ontario, K1H2X7.

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (Art. A602.2)

# THE EQUESTRIAN CANADA STATEMENT OF PRINCIPLES

Equestrian Canada (EC), the national equestrian federation of Canada, requires adherence to humane treatment of horses in all activities under its jurisdiction.

### All Persons shall be committed to:

- upholding the welfare of all horses, regardless of value, as a primary consideration in all activities;
   requiring that horses be treated with kindness, respect and compassion, and that they never be subject to mistreatment;
- ensuring that all Equestrians including owners, trainers and competitors, or their respective agents, use responsible care in the handling, treatment and transportation of their own horses as well as horses placed in their care for any purpose:
- providing for the continuous well-being of horses by encouraging routine inspection and consultation with health
  care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort
  and safety as a matter of standard operating procedure;
- providing current information on Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives:
- continuing to support scientific studies on equine health and welfare;
   requiring owners, trainers and competitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and actively promoting the development of and adherence to competition rules and regulations that protect the welfare of the horse.

The standard by which conduct or treatment will be measured is that which a person who is informed and experienced in generally accepted equine training and competition procedures would determine to be neither cruel, abusive, nor inhumane.

NOTE RE DRESSAGE TESTS: The tests are developed by the United States Equestrian Federation (USEF) and the United States Dressage Federation (USDF). The current versions (updated in 2023) are available on the EC website at <a href="https://www.equestrian.ca/sport/dressage/tests">www.equestrian.ca/sport/dressage/tests</a>.

Athletes are reminded to check the information/tests found in the Handbook against the EC website to ensure accuracy. Information on the EC website will always take precedence over the printed version.

# **RULES AND CONDITIONS**

### MEMBERSHIP

All Canadian entries are required to hold an active EC Horse Recording and have paid the EC Horse Recording annual Activation Fee to compete.. (Art. A602.4)

Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location. (Art. A602.5)

Per A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7)

# **VACCINATIONS**

Vaccination Certificate: All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations (Art 602.8). All horses attending Equestrian Canada sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event.

Coggins Test: The organizer requires the presentation of a negative coggins test dated within the current calendar year.

## **ENTRIES**

1. EC Registered or Licenced Coach Status is required for all Canadian residents coaching athletes at EC-sanctioned competitions. When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries must be in good standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments." (Art. 602.9)Note: Athletes aged 18+ may declare themselves to be self-coached by entering their own name and EC Sport Licence in the fields made available on the entry form. EC Sport License - An EC Sport Licence is required for residents of Canada who are competitors, owners or lessees, and individuals accepting legal responsibility for an entry. National (Gold) classes require a Gold (or higher) EC Sport Licence. A single event upgrade may be purchased by Bronze or Silver Sport Licence holders directly through EC.

Hors Concours/Non-competing horses may be entered based on stall availability. They must comply with all entry requirements and competition rules, and pay an additional fee of \$55 per horse plus stabling.

A801.5,6, Glossary. The Person(s) responsible (PR) for a horse must be an adult who has, or shares responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules. The PR is liable under the penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR. The Person(s) responsible is ultimately responsible for the condition, fitness and management of the horse and is alone responsible for any act performed by himself/herself or by any other person with authorized access to the horse in the stables, elsewhere on the grounds, or while the horse is being ridden, driven or exercised. PR must be an EC Sport Licence holder in good standing OR in the case of junior/minor owner entries, a parent/guardian is entitled to sign as PR. For adult entries into EC sanctioned competitions the PR shall be either the trainer, the owner of the horse or the competitor who rides or drives the horse during the EC sanctioned competition. For Junior entries into EC sanctioned competitions the PR. For Junior entries the PR may be either the trainer, the owner of the horse, or a parent/guardian of the Junior competitor.

# **SUMMER CLASSIC ENTRIES**

**Entries** open May 4, 2025 and must be received no later than June 1, 2025. Late entries, if accepted, will be charged \$45.00 per horse. Late entries will not be accepted on the day of the competition.

The completed entry must supply all information required and payment of fees.

Entries will be accepted online only through Compete Easy available at www.dressageatgingerwood.com

Online entries through Compete Easy must be paid by credit card or PayPal. There is an online processing fee of 5% of entry fees.

All Entries must be submitted through Compete Easy. No Mail or email entries will be accepted.

Preference will be given to 3-day Competitors.

Entries may have to be limited due to capacity reasons. Entries will be accepted in order received through Compete Easy.

**Ribbons** and prizes to be picked up at the Prize booth located next to show offices. High Point Award winners must be present in the show ring during mounted presentations to receive awards.

**STABLING:** Stabling is available on a first-come, first-served basis and required for all competitors. Show grounds open at noon on Thursday. Please book your stall with an entry. Please respect stall signs upon arrival. All stall users are required to clean out their stalls totally before departure. Shavings will be available at cost to competitors or may bring their own bedding (no straw please). Please note a limited number of tack stalls will be available.

Parking. Please follow parking and traffic signs on property. Trailer and car parking in the field next to the stabling barn.

No trailers or trucks are permitted to be parked in the stabling area during competition hours.



## **REFUND POLICY**

Before the close of entries, refunds of 100% minus processing fee and administration fee (\$60) will be refunded.

After the close of entries, refunds of 50% of class fees and 100% of stabling and other fees (less the \$60 administration fee) will be awarded with veterinarian's or medical doctor's certificate.

There are no refunds after final ride times are sent out (2 days before start of competition).

# **COMPETITION GUIDELINES**

1. The Rules of the EC recognize 3 categories of competitors (EC Article E 3.4)

CLASS CATEGORY	ELIGIBILITY TO COMPETE
Open (O)	All competitors (regardless of age and/or amateur/professional status)
Adult Amateur (Am)	All athletes who are no longer Juniors under rule E 3.4.3 (except as outlined in 3.4.2) individual Canadian competitors (see 3.4.2 – Amateur Status)
Junior (Jr)	Open to all athletes until the end of the calendar year in which they reach the age of 18.

• The **Amateur** category is for athletes over the age of 18 who are not earning remuneration from teaching or training horses or riders in the horse industry. All persons wishing EC amateur status must complete and sign the amateur declaration, which is on the sport licence application/renewal form, affirming their eligibility (E 3.4.2).

# MASTERS TEST OF CHOICE (Chapter 14 Section E Rules

The Masters Test of Choice is an Equestrian Canada (EC) Dressage class that provides senior athletes, 60 years and older, the opportunity to participate in a Dressage class that is exclusively their own in an environment that provides a fair playing field for senior athletes wherein each will compete against their peers at all levels of skill, from beginners to advanced. **DETAILS:** 

- A. Masters classes are open to athletes 60 years of age and above.
- B. Any EC sanctioned Dressage competition may offer the Masters Test of Choice.
- C. The class will be offered as a Miscellaneous Test of Choice class as per the EC Rules, Section A: General Regulations, A503 and will include all levels, national to FEI.
- D. In the event of a large number of entries, the class may be divided into two lower and upper Dressage levels with separate sets of ribbons
- E. The class will be included in the competition prize list with the appropriate entry fee.
- F. The class will feature one test per day and may have a class championship.
- G. Scores from Masters classes will not count towards EC championships or awards programs.
- H. Masters athletes may also compete in non-MastersDressage classes.
- I. To facilitate ease of riding, the following accommodations are available in the Masters Test of Choice:
  - i. Rising trot is optional in all trot work.
  - ii. Callers/athletes may use headsets (someone, e.g., a competition appointed supervisor (E.4.9.A.8. Exception) only, may stand beside the caller to ensure no coaching takes place).
  - iii. Entry bell/whistle can have a secondary indicator (e.g., the caller can raise an arm once the bell rings).
  - iv. Use of voice
  - v. Equipment accommodations may include any or all of the following:
    - Looped reins.
    - Converters on double bridle to create single rein.
    - Gel or fluffy seat covers; and/or,
    - Two whips.
- J. Judges for the Masters Test of Choice must be EC certified Dressage Judges at the Basic, Medium or Senior level.

# ANATOMEQ AND PANAGEA FREESTYLE EXTRAVAGANZA

For competing in freestyle classes in the National (Gold) show, a horse/rider combination must have obtained a minimum score of 60% in a Dressage test at the same technical level, or higher, as the freestyle they wish to enter. The dressage score may have been obtained at an EC Gold or Silver dressage competition prior to the competition, or may be obtained at the same competition in which they wish to enter the freestyle.

Freestyle music (MP3 file preferred) must be emailed to secretary@dressageatgingerwood.com before June 13, 2024. The email must contain competitor's name, horse's name, class #, and instructions (if any). Times for sound checks will be Friday June 20, 2025 after the completion of the last class. Note that there will be no sound manipulation – music will be played as received.



## **GENERAL**

For all EC competitions, athletes wishing to compete in **two categories** of a division (e.g. Junior/Open or Amateur/Open) will pay two entry fees, but may ride one test; their score will count for both categories. (For further details, see Article E 7.1 (4))

All tests can be found on the Equestrian Canada website.

An athlete may enter classes run under different licences at one competition providing the rider has the requisite sport licence/Horse Recording or EC National Passport. e.g. A rider may compete in gold/bronze, silver/gold etc. classes at one competition. (Article E 7.11.8 (5))

Substitutions: A horse/pony may compete with a substitute athlete providing the athlete is eligible to enter the class and pays any substitution fee required by the show organizer. (Article E 7.11.10)

A tack check by the official Steward will be done immediately AFTER the rider leaves the ring. It is the rider's responsibility to report to the Steward. Failure to report will result in elimination. (Article E 16.12)

Ride times will be available on website: www.dressageatgingerwood.com and posted at the stable. Ride Times posted by noon the day prior to the first day of classes will not be changed or additional classes added without due posted notice to all competitors at least 2 hours before the start of a class. (E.7.10.6)

Ribbons & prizes will be handed out at the ribbon booth after the completion of the show. Championship awards will be awarded during mounted presentations and riders must be present to receive awards. See schedule page for high point award requirements.

Drug Policy – Equine: Any horse entered in any class at a competition is subject to the requirement to pay drug testing fees may, while on the competition grounds and on the recommendation of the chair of the EC Equine Medication Control Committee or the chair's appointee, be selected for equine medication control testing. Drug testing fee for bronze competitors is \$4.00 while drug testing fee for Gold competitors is \$8.00.

Lunging (mounted) is not permitted under penalty of elimination. Lunging will not be permitted in the warm-up ring if another rider is present. (See Section E7.11.12(4))

Lunging is permitted in the warm up ring each day from 6:00am - 7:00am. Sign up is required in the show office to reserve a time slot of 20 minutes per horse.

Coaches: When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.

The Competition Committee reserves the right to govern all conditions of the competition and its entries.

Gingerwood Farm, Dressage at Gingerwood will not be held responsible for damage, injury or loss to persons, horses or property of exhibitors or spectators.

Any protest/dispute must be made in writing within 48 hours of the holding of the class concerned and addressed to the Competition Organizing Committee. The written protest/dispute must be accompanied by a deposit of \$100.00, cash or certified cheque. A copy must be sent to Equestrian Canada.

Show Management reserves the right to cancel classes due to hazardous weather conditions, acts of God, accidents or emergencies. Every effort will be made to reschedule classes. There will be no refunds for the cancellations due to hazardous weather, acts of God, accidents or emergencies

All tests will be ridden in a 20 metres x 60 metres ring.

Maximum Number of Tests/Day: A horse/rider combination may compete in only two consecutive levels and a maximum of four tests per day including the freestyle for Introductory, Training and First levels, and three tests per day including the freestyle for Second, Third and Fourth levels and all FEI tests. No horse may compete in more than four tests or rides combined per day, including the freestyle

Competition numbers must be worn and be visible in schooling and exercise areas and the competition ring at all times. Protective head gear must be worn when mounted on show grounds. (Article E 4.0)

A competition may reserve the right to refuse an entry providing the reason for refusal is clearly stated in the prize list (Article A805).

Pony: If entered in pony class, the pony must have a current measurement card. Contact competition if the pony requires measurement; arrangements will be made with the judge to do measurement prior to the start of the show.

The warm-up and competition rings are identified with posted signs. Access to the competition ring will be available Thursday June 19 from 12:00-9:00 pm. Warm-up ring will be open 1 hour prior to the start of the competition until 30 minutes after completion of the last scheduled ride and subject to grooming. Competitors may only use designated warm up areas

Dressage Canada levy fee for competitors is \$12 per entry. It must be collected by competition organizers and remitted to Equestrian Canada. Dressage Canada will use it for domestic development with emphasis on provincial and regional education and/or development programs.
